About the Australian Infrastructure Budget Monitor

We rank Australia's governments by measuring and comparing infrastructure funding levels, as a share of each government's total budget expenditure.

Purpose

To provide:

- a fair comparison of infrastructure funding across governments which vary in scale; and
- an analysis of the increase or fall in the priority of infrastructure funding within each jurisdiction's budget, year to year.

What is 'infrastructure'?

We measure General Government sector infrastructure funding, which includes 'public' infrastructure, like:

- roads;
- passenger railways;
- hospitals; and
- schools etc.

We exclude 'commercial' government-owned infrastructure such as ports, telecommunications or electricity companies, noting that these types of infrastructure are funded by consumers.

Methodology




Figure 1: 2017/18 Australian infrastructure funding levels, ranked by share of budget expenditure

We rank jurisdictions on infrastructure funding as a proportion of total General Government expenditure averaged over the four year forward estimates. We also detail each jurisdiction's four year total funding programme and the increase or cut in infrastructure funding compared to the preceding budget (see Figure 1).

We use infrastructure funding figures reported in government budgets where available. In other cases we use the sum of purchases of non-financial assets and finance leases (capturing Public Private Partnership type expenditures) as a proxy.

Total General Government expenditure is calculated by adding total expenses and net acquisitions of nonfinancial assets.

This document has been updated since its original release to reflect changes in methodology.

Analysis

The 2017/18 Australian Infrastructure Budget Monitor shows that the jurisdictions responsible for the bulk of brownfield asset reycling are now funding the highest levels of infrastructure in the country.

NSW wins a solid first place – dedicating 14.29 per cent of its Budget to infrastructure – worth \$49.65 billion, over four years.

ACT comes an impressive second – with 13.46 per cent of the Territory's Budget funding put towards infrastructure; worth (a more modest) \$3.24 billion, in monetary terms.

Victoria ranks third, with 12.54 per cent of of its Budget worth \$32.84 billion, commmited to infrastructure.


Queensland comes fourth with 11.11 per cent of its Budget dedicated to infrastructure funding, which is worth \$26.73 billion over four years.

WA ranks last in this year's rankings, with \$8.86 billion in infrastructure funding over four years to FY2020/21 making up just 6.98 per cent of its Budget. The declining trend in infrastructure funding reflects the WA Government's fiscal challenges and a similar policy position to Queensland of prohibiting asset recycling.

Insights

- Together, NSW and Victoria field 61.9 per cent of Australian infrastructure funding activity.
- General Government infrastructure funding totals over \$133 billion across all jurisdictions.
- NSW, Victoria, Queensland, NT and Tasmania have increased infrastructure funding by a combined total of \$10.26 billion over the forward estimates.
- WA, SA, ACT and the Commonwealth have decreased infrastructure funding by a combined total of \$6.78 billion over the forward estimates.


Figure 2: Who's funding what? National infrastructure funding, share of total, by jurisdiction (FY2017/18 to FY2020/21)*




Figure 4: Australian Capital Territory General Government Infrastructure Funding
















Figure 10: Western Australia General Government Infrastructure Funding


